

Administrative details and terms and conditions for the University of Stirling scholarship for Healthcare Sector (Updated 6 May 2024)

1. Value

A scholarship equivalent to 10% of the programme fees will be offered to successful applicants who have been offered a place at the University of Stirling - SIM Master of Science Gerontology and Global Ageing programme. The scholarship amount will be used to offset the recipient’s course fees offered at SIM. The University of Stirling and Singapore Institute of Management Pte. Ltd. (“SIM”) have the discretion to cap the quantum of any scholarship.

2. Eligibility Criteria

2.1 To qualify for the scholarship the recipient will need to meet the following admission criteria as well as the English Language requirements.

All other qualifications will be evaluated on a case-by-case basis and may be subject to interview. All admissions are based on merit and are subject to the approval of the University

2.2 The recipient must have completed the application process and paid an application fee via the SIM online application system by the cut-off date to be considered for the scholarship.

2.3 Conditions under which the scholarship will not be offered.

- A) If you have previously studied on the MSc Gerontology and Global Ageing programme with University of Stirling.
- B) If your application has been rejected at the sole discretion of [the University.
- C) If you have withdrawn your application at any point prior to course commencement.
- D) If you withdraw from the programme at any point upon class commencement.

2.4 Students may reject the scholarship offer in writing.

3. Course Fee payment

Subject to eligibility, the scholarship equivalent to 10% of the programme fees will be deducted from the 4 payment instalments during the two-year programme duration.

4. Terms and conditions upon receiving the scholarship.

The scholarship is tenable for the minimum period required to complete the full course of study, as stipulated by the University of Stirling's programme regulations. There is no bond to the scholarships.

Recipients must adhere to the following conditions:

- A) Attempt all tests, assessments, and examinations. University of Stirling and SIM might revoke the scholarship and have recipients refund the amount awarded if he/she did not demonstrate due diligence in his/her studies.
- B) Contribute actively to the SIM - University of Stirling community such as sharing of learning journey at briefings and fairs.
- C) You consent to the University and SIM collecting, using, processing, and/or disclosing your personal data in relation to this Scholarship.
- D) Comply with any other reasonable instructions from the University of Stirling and SIM.

5. Suspension or Termination

SIM - University of Stirling have the authority to suspend or terminate and may at its joint discretion vary the terms and conditions and/or amend or issue additional guidelines with respect to the Scholarship, with due notice given. All such guidelines shall be deemed to be part of the terms and conditions of the Scholarship. The University of Stirling and SIM reserve the right not to award any scholarship. The decision of the selection committee is final. Enquiries or disputes surrounding its decisions will not be entertained.

6. How to Apply

The Master's scholarship application opens May 2024 and is applicable for postgraduate courses commencing from September 2024. You will be considered for the scholarship as long as you have submitted all completed documents and paid in full the application fee by the stipulated deadline stated in point 2.2.
